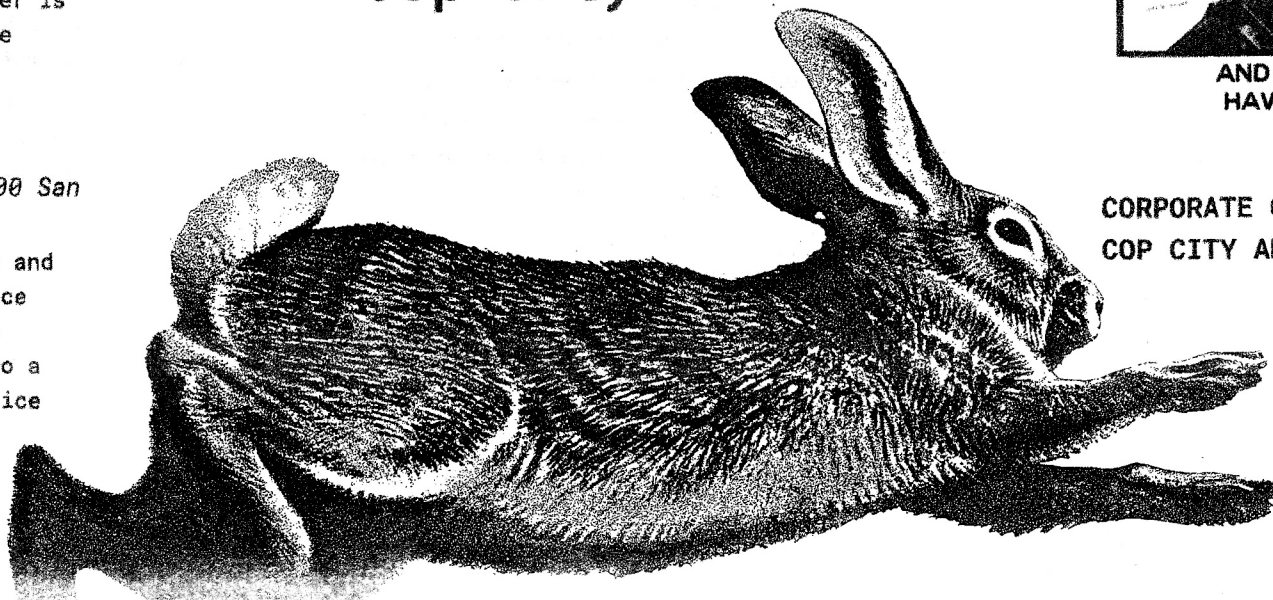

GI Partners, an investment firm based in San Francisco, recently acquired Atlas Technical Consultants for \$1billion. Atlas Technical Consultants owns many smaller companies, one of which is Long Engineering. Long Engineering has done work for the primary contractor of the Cop City project and one of the largest privately held construction firms in the US: Brasfield and Gorrie, LLC.

Vehicles owned by Atlas have been spotted at Michelle Obama Park, an area that is part of the controversial land swap between DeKalb County and Ryan Millsap - founder of Shadowbox Studios, Chairman and CEO of both Blackhall Group and Blackhall Americana, and adjunct professor at the USC Price School of Public Policy - who stands to profit from the development of Cop City. This land swap also threatens the Intrenchment Creek Park portion of the Atlanta Forest.
